Go View It Privacy Policy

We, Go View It (T/O Assured Group), headquarter, Heathcote Industrial Estate, Warwick (“Go View It”), take the protection of your personal data seriously, including implementing all reasonable steps to comply with applicable data protection laws. The following explanation provides an overview of the information collected on this website, including information which may constitute your personal data.

Please read this policy carefully. By visiting our website, you acknowledge and agree to the practices described on this Privacy Policy.

For the purpose of the applicable data protection law, Go View It is the controller of any personal data collected from you on this website.

Information collected automatically on this website.

We collect and automatically store information on our Server Log Files, which we receive from your browser. This includes,

- Browser type and version
- The operating system used
- Resolution and colour depth settings
- Referral URL (the previous webpage visited, if applicable)
- Host name/IP address of the accessing computer
- Time and date of the server request

Information you provide

In using our website, you may voluntarily provide personal data to us in the following ways:

- By filling in forms on our website (for example, our “Go View It – contact form”; or
- By corresponding with us by phone, e-mail or otherwise using the contact details provided on our website

Typically, the personal data you give us may include your name, address, e-mail address, phone number, and any personal details required to resolve your inquiry or complaint. You may also contact us via our website to apply for a job, biography, career history, qualifications, resume / CV etc)

Use of personal data

The following is an overview of our purpose for using your personal data. Please remember that additional information may be provided to you in a separate notice from time to time. All processing (i.e. use) of your personal data is justified by a “lawful basis” for processing. In the majority of cases, processing will be justified on the basis that :

You have consented to the processing (e.g. where you sign up for our newsletter) ; the processing is necessary for us to comply with the relevant legal obligation; or the processing is in our legitimate commercial interests, subject to your interests and fundamental rights (e.g. our use of analytics technologies as described below).

We use the personal data we collect to :

- Improve our website and services generally;
- Customize our website to users 'needs
- Correspond with users to resolve their queries and complaints;
- Provide you with any services you request;
- Send you marketing communications (i.e. our newsletter) where it is lawful for us to do so;
- Consider your job application and contact you regarding that application.

Disclose of personal data

Go View It is part of a group or companies, and from time to time it will be necessary to pass your information between our overseas offices and our affiliated business. We may also appoint third party service providers (who will operate under our instructions) to assist us in providing information or services to you or to manage and improve the website and these third parties may need access to your personal data.

In relation to both internal transfers and the use of service providers, if personal data is transferred outside the EEA we will take steps to ensure that the information receive the same level of protection as if it remained within the EEA, including by entering into data transfer agreements, using the E commission approved Standard Contractual Clauses, or by relying on certification schemes such as the EU- US Privacy Shield. You have a right to details of the mechanism under which your data is transferred outside of the EEA.

We may share your personal data with third parties if we, or substantially all of our or the relevant affiliated company's assets are acquired by a third party, in which case personal data held by us about our users may be one of the transferred assets.

We will also respond to requests for information where required to do so by law, or when we believe that disclosure is necessary to protect our rights and/or comply with a judicial proceeding court order, request from a regulator or any other legal process serves on us.

Cookies and related technology

A cookie is a small file that can be placed on a device's hard drive or on a website server designed to store a modest amount of data about a website session. This data is automatically stored in the user's browser. However, it is not necessary to accept a cookie, and you can in fact modify your browser so that it will not accept cookies.

A session cookie only applies to a session and is erased when the user closes their browser. The data collected is not store on the hard drive but rather in the temporary memory and is used to track pages that a user has visited during a session.

A persistent cookie is stored on a user's hard drive until a pre-defined expiration date or the user deletes the cookie. This cookie is used to collect user preferences for specific websites or browsing history.

Our specific uses of cookies and related technology are as follows,

DoubleClick	This is used to target advertising based on what is relevant to you, to report on the effectiveness of advertising, and to avoid showing ads which you have already seen.	
Gtastic	This is used to harness Google Content Delivery Network to load content quickly.	
Google Analytics	This allows us to measure how you interact with the content on our websites. This measurement schema tracks all general web statistics and also include KPI's and segments that have been customised to the Go View It Platform.	
Facebook cookies	This allows Facebook to show relevant ads for our services to people who have visited our website.	
Go View It Analytics	This allows us to measure how end-users interact with our websites. This measurement schema tracks all general statistics and also include KPI's and segments that have been customised to the Go View It Platform. All of the data collected by Go View It Analytics cookie is stored in data centres geo-localised to the Customer. Under no circumstances is the IP or any other personal data of the end-user collected and stored. Insights are gleaned from aggregated data in the form of dashboards and reports.

Your Rights

Subject to applicable law, you may have some or all of the following rights in respect of your personal data:
